The 5-4 majority said the Obama-era rule was likely illegal when it issued in 2015. The case, brought by several states, challenged rules issued by the U.S. Department of Labor that under the agency's authority, the nation's biggest companies must meet a certain quota of "U.S. workers first" when they want to hire new, non-supervisory workers overseas. The ruling was a victory for business groups, who said the regulation was too onerous. "The government cannot... mandate that companies impose U.S. workers first for these positions," Justice Samuel A. Alito Jr. wrote for the majority. "That is a matter of private conduct not subject to federal legislation." The rule also violated the Constitution because it "imposes a sizable and unprecedented regulatory burden" on American businesses, he said. The
